### **PROSPECTUS FOR ADMISSION TO B Sc NURSING COURSE 2017 (UNDER MANAGEMENT & NRI QUOTA)**

#### **1. INTRODUCTION:**

The Academy of Medical Sciences (ACME), Pariyaram, Kannur District established on 17-11-1993, is a society registered under the Societies Registration Act XXI of 1860 with its registered office at Pariyaram. The main objective of the society is to organize and conduct Graduate and Post Graduate courses, training in Modern Medicine, Nursing, Pharmacy and to provide research facilities for carrying on research in all disciplines of modern medicine and allied sciences keeping in view of the socio medical and socio economical needs of the state of Kerala. The Academy has to function in close collaboration with the Kerala State Co-operative Hospital Complex and Centre for Advanced Medical Services Limited (KCHC).

Accordingly the Academy offered Medical, Dental, Pharmaceutical, Nursing and Paramedical courses and imparted respective quality education in Medical Science since 1995, Dental Science since 2004, Nursing since 2002, Pharmaceutical Science since 2003 and Paramedical Science courses since 2006. Pariyaram Medical College is the institution which conducts medical education under ACME

**College of Nursing, Pariyaram**, one of the constituent institutions of ACME, marked its entry in the field of Nursing Education in 2002 with a view to impart quality nursing education to all aspiring students. The College is affiliated to Kerala University of Health Sciences and is recognized by the Kerala Nurses & Midwives Council and Indian Nursing Council per their Order No. G.5290/02/NC dated 26/09/2014 & No. 18-16/2299-INC dtd. 12.11.2005 respectively.

Ever since its inception in 2002, the College has been enterprisingly growing in strength and ambit with the ultimate objective of producing Professional Nursing Graduates, Post Graduates and Nursing Specialists who would be able to render comprehensive health care to the society in various settings and participate and co-ordinate nursing services and nursing education at different levels. The College is attached to Pariyaram Medical College Hospital, a 1200 bedded super specialty hospital where the students are given highly professional training.

This prospectus for admission to B Sc. Nursing Degree Course 2017 which is subject to the approval by the Admission Supervisory Committee appointed by the Govt. of Kerala is published herewith. Any change in the prospectus, if made by the Admission Supervisory Committee shall be included in the prospectus as well as published in the website of the institution immediately after its receipt. The prospectus contains general information, rules and regulations relating to admission under Management open / Non Resident Indians (NRI) quota 2017 of B Sc. Nursing.

## **2. CAREER OPPORTUNITIES**

Nursing is a health care profession that involves years of training and continued specialized education to care for patients in a variety of settings. They are the most trusted health care professional and the heart and soul of health care systems. They can practice independently and provide service individually even though they collaborate with all members of the health care team. The field has a wide range of career opportunities, ranging from entry level practice to doctoral level research. Nurses are hands-on health professionals who provide focused and highly

personalised care. Although an entry level nurse can find out a job for herself with a B Sc Nursing Degree, there are growing numbers of Master of Sciences in Nursing and Doctoral programs, designed to meet the increasing demand for more highly skilled professionals in the workforce. Once you are a professional nurse, you might choose to focus on a particular specialty. There are numerous specialty options, each of which has its own educational/certification requirements. Nursing Professionals who are highly qualified and interested in teaching can also work as Nurse Educators at different levels of Nursing Programs.

### 4. ELIGIBILITY CRITERIA FOR ADMISSION:

Indian citizens only are eligible for admission to B Sc Nursing course. The applicant should have passed higher secondary examination of the board of Govt. of Kerala, or equivalent examination recognized by the Universities in Kerala. He /She should have secured an aggregate of not less than 50% marks in Physics, Chemistry and Biology put together. Applicants who have passed their qualifying examination from any place other than from the state of Kerala shall produce a certificate of its recognition and equivalency in the state of Kerala and Migration certificate.

**Age: The applicant should have completed 17 years as on 31st December 2017. No relaxation in age is allowed.**

### 5. SELECTION PROCEDURE

**a) Management Quota:** Selection under this quota is based on merit which will be decided taking in to account of the marks obtained for optional subjects in the qualifying examination and a personal interview. To achieve this, 80% marks are given for the marks obtained in PCB of qualifying exam and 20% for the interview.

**b) NRI Quota:** Those who apply under NRI quota should satisfy all the conditions stipulated in GO (MS) NO.34/2013/H & FWD dated 05-02-2013, GO (MS) No.193/2013/H & FWD dated 22-05-2013 and GO (MS) NO.243/2014/H & FWD dated 06-08-2014 of the Govt. of Kerala regarding NRI status. NRI applicant is he/she who depends upon his/her father/mother/brothers & sisters (inclusive of first cousins)/husband/wife/half brother/half sister /Adopted father/ Adopted mother working abroad. Separate application is required for considering admission under Management open quota and NRI quota. Applicants seeking admission under NRI quota should produce the following certificates/ documents apart from other certificates/documents required for management open quota.

- 1) Copy of Passport and Visa attested by the respective Indian Embassy/ Consulate.
- 2) If the Visa is not stamped, employment certificate duly attested by the respective Indian Embassy/Consulate.
- 3) Sponsorship certificate.
- 4) Relationship Certificate from Village Officer.
- 5) NRI Bank Account Details

**6. FEES:**

Fees for Management open quota and NRI quota will be as fixed by the Govt. subject to approval by the Admission Supervisory Committee/Fee Regulatory Committee. Fees consented/agreed at the time of admission shall be paid within the stipulated time every year. Refund of fees will be made to students who got admission for B Sc Nursing or any other degree courses under Merit category through the Centralized Allotment Process (CAP) of Govt. of Kerala in Govt. Colleges. Such refund will be paid only after the closing of admission. The students admitted under Management/NRI quota would not be relieved under any circumstances except if they got admission for B Sc Nursing or any other courses under Merit category through the Centralized Allotment Process (CAP) of Govt. of Kerala in other Self Financing Institutions.

**a) Liquidated Damages:** If any candidate discontinues after closing of admission to join other courses/colleges or for other purposes, he/she is liable to pay liquidated damages equal to that of the total fees for the entire course. Liquidated damages shall be levied irrespective of annual income of the family. Legal action under Revenue Recovery Act shall be taken to recover the damages in case of failure to remit the liquidated damages. The applicant and his/her parent shall execute a bond in stamp paper to the effect that they agree to pay liquidated damages. In such cases Transfer

certificate and other certificates of the student will be issued only after the payment of liquidated damages.

**b) Special Fees:** Special fees applicable shall be paid at the time of admission itself. Students getting admission will be insured against illness, accident etc. and annual premium thereon will be collected at the time of admission.

## **7. HOW TO APPLY:**

Application form will be available online at our website [www.mcpariyaram.com](http://www.mcpariyaram.com) from **19/06/2017 to 30-06-2017**. Fee for application form is Rs. 500/- for Management and Rs. 750/- for NRI seats. If you apply for both Management and NRI seats, you should tick both the options and pay Rs.1250/- as Demand Draft drawn in favour of Principal, College of Nursing, ACME, Pariyaram payable at Kannur. Separate application is required for separate quota. After submission of online application a computer generated registration details should be sent to the registered e mail ID. The candidate need to take a printout and sign the document. The signed hard copy of the application along with DD and relevant documents should be sent to The Principal, College of Nursing, ACME, Pariyaram Medical College P.O 670503 Kannur District on or before **5<sup>th</sup> July 2017**. The online application without hardcopy, DD for required fee and other documents will be rejected, without further notice.

- 1) Demand Draft of Application Fee.
- 2) Self attested copy of the mark list of qualifying examination.
- 3) Self attested copy of relevant page of SSLC/CBSE/other equivalent exam., certificate to prove the date of birth and age.
- 4) Self addressed envelope with the stamp of Rs. 5/affixed.

The applicants shall produce the original certificates/documents mentioned above at the time of counseling/selection.

Belated, incomplete or defective applications will be summarily rejected.

## **8. COUNSELING/INTERVIEW, SELECTION AND ADMISSION:**

Counseling/interview will be held at the College for selection and admission of students to the course. The selected candidate may join the course on that day itself, if he is prepared to pay the fees and special fees and submit all essential testimonials/documents. However he/she is at liberty to avail 3 more days to remit

the required fees and ensure confirmation of admission. Failure in payment of required fees within the time limit mentioned above will result in cancellation of admission. Part payment of fees will not be accepted. The date of counseling/interview will be intimated by e-mail or by post to the short listed candidates as well as published in the institutional website. Important dates that are to be born in mind are furnished in Annex. 1

**9. OTHER ESSENTIAL CERTIFICATES/DOCUMENTS TO BE PRODUCED AT THE TIME OF SELECTION AND ADMISSION:**

Following are the essential certificates/ documents that are to be produced at the time of selection/Admission.

- 1) Transfer Certificate from the institution last attended and Conduct Certificate.
- 2) Certificate of recognition and equivalency in the State of Kerala and Migration Certificate as mentioned in Para 4 above, if applicable.
- 3) Physical Fitness Certificate in the prescribed format.
- 4) Vaccination certificate against hepatitis, MMR and Chickenpox.
- 5) Joint undertaking as per the provisions of anti-ragging verdict by the Hon'ble Supreme Court of India.

**10. VERIFICATION OF DOCUMENTS:**

The Principal shall be personally responsible for verification and satisfaction of the correctness of the records produced by the candidates at the time of admission.

**11. RESIDENTIAL ACCOMMODATION:**

Available accommodation will be provided to students subject to the terms and conditions of the institution. Preference will be given to those who hail from outside the home district.

**12. COLLEGE UNION:**

Students may actively participate in the sports and cultural activities of the college as well as of the University under the banner of College Union

**13. PTA:**

The institution has an active Parent Teachers Association to which the parents of the beginners may also extend their considerable contribution. Parents should feel free to interact with the teachers quite frequently so as to enable the formers' wards to perform well in their studies.

**14. REDRESSAL OF GRIEVANCES:**

Grievances/complaints if any regarding selection/admission may be brought to the notice of the Principal of the College/Director of Academy of Medical Sciences for taking remedial measures promptly.

- 15. DISCIPLINE:** Selected and admitted students should obey the rules and regulations of the institution strictly. Failure to observe absolute discipline will attract stringent disciplinary action. 80% attendance is compulsory in each academic year for theory and 100% in practical. Students should wear prescribed uniform with name plate exhibited on the chest during class time. They are expected to wear respectable dresses. Use of mobile phone is strictly prohibited. Smoking, consumption of alcohol and use of psycho tropic substances are totally prohibited. The students should pay adequate attention in neatness and cleanliness and sincerely co-operate with the authorities in maintaining a healthy environment in the campus.

**16. MALPRACTICE:**

Malpractices of any sort for securing admission are nothing but illegal. If a candidate is found to have indulged in malpractices at any time, his/her admission will be forfeited followed by initiation of criminal proceedings.

**17. RAGGING:**

As per Kerala Prohibition of Ragging Act 1998, ragging is a criminal offence. Ragging means doing of any act by disorderly conduct against a student of an educational institution, which causes or likely to cause physical or physiological harm or raising apprehension or shame or embarrassment to that student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a student to do any act or to perform something which such student will not in the ordinary course be willing to do. Whoever commits, takes part in or abets, aids or protects a student indulged in ragging within or outside the campus shall be liable for deterrent disciplinary proceedings coupled with criminal action. The institution has to abide by the directives of the Hon'ble Supreme Court of India dated 16th May 2007 in SLP No.(S) 24295 of 2007, SLP (C) No. 24296-99/2004 and WP (CrI) No. 173/2006 & SLP(C) No. 14356/2005. Every student and his parent/guardian have to submit a joint undertaking at the time of admission in Annex. 4 which is mandatory for getting admission. The Principal shall take all the preventive and Anti-ragging measures and ensure the strict enforcement of law of ragging.



**18. GENERAL:**

All concerned should read this prospectus carefully and comply with the instructions scrupulously. Disputes pertaining to the selection and admission, if any, shall fall within the jurisdiction of the Hon'ble High Court of Kerala. Any other items not specifically covered in this prospectus will be decided by the Principal in consultation with the Management of the Academy and her decision will be final.
